## Magyar Telekom Board of Directors decision concerning separation of the Company's passive mobile infrastructure

Budapest – May 13, 2025 – Magyar Telekom (Reuters: MTEL.BU and Bloomberg: MTELEKOM HB, hereinafter the "Company"), the leading Hungarian telecommunications service provider announces that its Board of Directors decided to propose to the General Meeting the separation of the Company's passive mobile infrastructure portfolio into a fully owned subsidiary.

In line with the Company's extraordinary announcement on February 25, 2025, the Company's management is currently preparing the detailed financial analysis, accounting, legal and other documentation necessary for the separation. The Board of Directors decided to convene the Extraordinary General Meeting (EGM) of the Company for June 26, 2025 and to propose to the EGM the approval of the separation.

The separation itself would have broadly neutral impact on Magyar Telekom Group's financial performance as the associated upsides, such as enhanced focus on operational efficiencies, dedicated expert management team and separate strategical focus would mostly offset the additional expenses.

The total asset value of the passive mobile infrastructure being separated, spread across ca. 2,800 sites is HUF 52.7 billion. Following the separation, it is expected that in 2026, annual EBITDA AL generation of the separate entity – including the ca 90% internal revenues - would amount to HUF 12.1 billion.

Subject to the decisions of the EGM and the fulfillment of other conditions, including the decision by the competent court, the separation would be completed in Q4 2025.

The Company expects to publish the announcement on convening the EGM, including the detailed agenda and related proposals on May 26, 2025.
