Magyar Telekom purchased treasury shares

Budapest – March 20, 2025 – Magyar Telekom (Reuters: MTEL.BU and Bloomberg: MTELEKOM HB, hereinafter the “Company”), the leading Hungarian telecommunications service provider, announces that in accordance with its extraordinary announcements on February 22, 2024 and on March 13, 2025, for the purpose of shareholders’ remuneration, the Company purchased 314,943 Magyar Telekom ordinary shares (HU0000073507) at an average price of HUF 1,751.12 per share on March 20, 2025. The share purchase was carried out on the Budapest Stock Exchange via daily trading through Erste Investment Limited, as investment service provider. Following this transaction the Company holds 30,933,871 treasury shares.
