Magyar Telekom announces fulfillment of its share buyback

Budapest – March 21, 2025 – Magyar Telekom (Reuters: MTEL.BU and Bloomberg: MTELEKOM HB, hereinafter the “Company”), the leading Hungarian telecommunications service provider, announces that in accordance with its extraordinary announcements on February 22, 2024 and on March 13, 2025, for the purpose of shareholders’ remuneration, the Company purchased 59,247 Magyar Telekom ordinary shares (HU0000073507) at an average price of HUF 1,786.43 per share on March 21, 2025. The share purchase was carried out on the Budapest Stock Exchange via daily trading through Erste Investment Limited, as investment service provider. Following this transaction the Company holds 30,993,118 treasury shares.

Between March 17, 2025 and March 21, 2025 the Company purchased a total of 956,705 Magyar Telekom ordinary shares (HU0000073507) in the total value of HUF 1.7 billion on the Budapest Stock Exchange via daily trading as listed below, fulfilling the share buyback announced in the extraordinary announcement on March 13, 2025, which consequently has been closed on March 21, 2025.
