Magyar Telekom completes its share buyback

Budapest – June 24, 2025 – Magyar Telekom (Reuters: MTEL.BU and Bloomberg: MTELEKOM HB, hereinafter the “Company”), the leading Hungarian telecommunications service provider, announces that in accordance with its extraordinary announcements on February 25, 2025 and on May 14, 2025, for the purpose of shareholders’ remuneration, the Company purchased 65,000 Magyar Telekom ordinary shares (HU0000073507) at an average price of HUF 1,785.17 per share on June 24, 2025. The share purchase was carried out on the Budapest Stock Exchange via daily trading through Erste Investment Limited, as investment service provider. Following this transaction the Company holds 52,857,928 treasury shares.

The Company purchased between May 19, 2025 and June 24, 2025 on the Budapest Stock Exchange - via daily trading and negotiated transactions - a total of 21,864,810 Magyar Telekom ordinary shares (HU0000073507) in the value of HUF 39.1 billion, as listed below and with this reached the full amount of the share buyback launched for the purpose of shareholder remuneration as announced on February 25, 2025. The Company completed the share buyback announced in the extraordinary announcement on May 14, 2025, thus it has been closed on June 24, 2025.
