Magyar Telekom purchased treasury shares

Budapest – May 27, 2025 – Magyar Telekom (Reuters: MTEL.BU and Bloomberg: MTELEKOM HB, hereinafter the “Company”), the leading Hungarian telecommunications service provider, announces that in accordance with its extraordinary announcements on February 25, 2025 and on May 14, 2025, for the purpose of shareholders’ remuneration, the Company purchased 48,000 Magyar Telekom ordinary shares (HU0000073507) at an average price of HUF 1,731.89 per share on May 26, 2025. The share purchase was carried out on the Budapest Stock Exchange via daily trading through Erste Investment Limited, as investment service provider. Following this transaction the Company holds 40,193,756 treasury shares.
